SWIMMING POOL AREA SAFETY INSTRUCTIONS

Les Passetries

1. Please note the safety of yourself and your children is your responsibility.
2. All children must be accompanied by an adult who can swim and is sober at all times.
3. Never leave the pool area unattended whilst children are in the pool area.
4. Please ensure the gates to the pool area are closed after entering and leaving the area.
5. Please lock the gates to the pool area when it is unsupervised (and at the end of your stay).
6. Never wedge the gates open.
7. No diving.
8. No glasses or glass bottles in the pool area.
(Plastic items are provided in the gite).
9. Know where your children are at all times.

HOLIDAY RENTAL BOOKING CONDITIONS - LES PASSETRIES, VERNAIL-LE-FOURRIER, FRANCE

1. Definitions.

The Property: Known as Les Passetries, Vernail-Le-Fourrier, France.

The Owners: SCI Les Passetries equally owned by Mr. & Mrs. Bowden and Mr. & Mrs. Lowe.

The Client: The leader of the party renting the property who warrants that he/she has the authority to act on behalf of all the members of the party. The Client should be at least 21 years old.

2. Booking your holiday.

The Booking Form and Swimming Pool Area Safety Instructions Form should be completed by the Client and returned to the Owners as directed, an acknowledgement will be sent by the Owners to the Client within seven days. By completion of a Booking Form and Swimming Pool Area Safety Instructions Form the Client accepts and agrees to comply with the conditions thereon detailed.

3. Payment for your holiday.

The Client shall forward with their booking form an initial deposit of 20% of the rental, unless the required holiday dates commence within ten weeks of the booking date, when the full rental is payable. At the time the full rental is payable a security deposit of 125 GBP is required which will be refunded within two weeks of the end of your holiday subject to there being no damage, losses or cleaning required. The attention of the Client is drawn to the fact that the Clients liability to the Owners is not limited to the amount of the security deposit.

4. Cancellation of the holiday by the Client.

In the event that the Client wishes to cancel the booking a notice in writing, sent by registered post, shall be forwarded to the Owners. Cancellations are subject to a charge payable by the Client to the Owner as follows: cancellation received before departure - more than 70 days notice deposit only, 70-43 days 30% of rental, 42-29 days 50% of rental, 28-15 days 75% of rental, and less than 14 days no refund. The security deposit will be refunded in full by the Owners to the Client.

5. Cancellation of the holiday by the Owners.

In the event that the Owners wish to cancel the booking a notice in writing, sent registered post shall be forwarded to the Client together with a full refund.

6. Holiday Accommodation.

The accommodation, grounds, outbuildings, facilities including swimming pool provided are entirely at the Clients risk and no liability is accepted by the Owners for their use.

The Property shall be available for occupation from 4pm on the first day of the holiday rental period and shall be vacated by 10am of the last day of the holiday rental period.

The Property shall not be occupied by more than 5 adults/children and one baby unless prior agreement/payment has been made with the Owners.

The Clients are requested to leave the property including grounds in the same condition of cleanliness and tidiness that the property was found upon arrival. Refer to clause 3.

The Owners do not accept liability for the failure of any equipment, plant and machinery provided for use at the Property, but will upon receiving notification endeavor to rectify any problems as a matter of urgency.

The Owners do not accept liability for any failure of water, electricity, satellite, or telephone services outside the control of the Owners, but will upon receiving notification endeavor to rectify any problems as a matter of urgency.

The Owners do not accept liability for any loss, injury, accident or death of any Clients during their occupation of the property and Clients are advised to ensure they have adequate insurance accordingly. The attention of Clients is specifically drawn to the need to supervise at all times the use of the swimming pool (please refer to the Swimming Pool Area Safety Instructions Form as noted in clause 2).

Under no circumstances shall the Owners liability to the Client exceed the amount paid to the Owner for the rental period.

The Property is drained via a septic tank. Clients are requested not to use bleach, antibacterial cleaners nor to dispose of condoms, sanitary products nor disposable nappies down lavatories. The cost to remedy drainage blockages will be deducted from the security deposit.

Clients are requested to secure the property when leaving closing all windows and locking doors using the keys provided (replacing the front door key within the keysafe).

7. Generally.

Pets are not allowed within the property, grounds or outbuildings.

The property is non-smoking.

The Owners do not accept liability for any damage to motor vehicles within the grounds of the property.

The Owners or their representatives reserve the right to enter the Property to undertake any necessary repairs to the structure, fittings, equipment, plant or machinery.

Clients are requested to respect the privacy and well being of neighbours.

These conditions will be governed and construed in accordance with the Laws of England and Wales and the Owners and Client submit to the exclusive jurisdiction of the Courts of England and Wales.
